Pakistan Kidney and Liver Institute and Research Center, Lahore intends to prequalify eligible vendors having valid Drug Sale License, registered with Income Tax and Sales Tax Department and working since 1st January 2018 for "Daily Local Purchase of Surgical Disposable Consumables(Local/Imported) on Day To Day Basis for PKLI & RC"

Applications for pre-qualification shall be submitted in sealed envelope addressed to Head of Procurement, PKLI & RC, Lahore on April 19, 2021 till 1100 Hours and shall be opened on same date at 1130 Hours. Application shall be clearly marked as "Prequalification of Vendors for Daily Local Purchase of Surgical Disposable Consumables(Local/Imported) on Day To Day Basis for PKLI & RC"

All the intending applicants are required to submit a bid security in shape of CDR /Pay Order Bank Guarantee/ Bankers Cheque worth amounting to Rs. 430,000/- (1% of estimated cost) in favor of Pakistan Kidney and Liver Institute and Research Center, Lahore.

A complete set of the prequalification documents can be downloaded from the official websites of the PKLI & RC, Lahore. (www.pkli.org.pk). For participation, written application along with original receipt of tender deposit fee of Rs. 1,000/- (non-refundable) under Account head "Pakistan kidney and liver institute and research center" **Faisal bank saving Account No:3032307900077862** to be submitted with Prequalification documents.

A pre-bid meeting will be held on April 12, 2021 in conference room, PKLI at 1100 Hours.

In case the date of opening is declared as a public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of applications accordingly. The time and date shall remain the same.

- 1. Local Purchase (L.P) may be ordered / procured through brand name.
- 2. To prequalify, applicant must meet the evaluation criteria.
- 3. Failure to the meet the criteria will leads to disqualify.
- 4. The Request for Quotation (RFQ) shall be circulated among the prequalified applicants through email or same shall be placed on PKLI & RC website.
- 5. All prequalified applicants shall submit the RFQ in sealed envelope as per terms and conditions mentioned in RFQ, whereas RFQ Shall be opened in the presence of the committee and rate(s) shall be announced keeping in view the highest discount offered Rate on Market/Trade Price (s).
- 6. Purchase order shall be awarded to the lowest firms based on highest discount offered on Market Price/Trade Price applicant.
- 7. Prequalified firm shall be bound to provide the demanded/desired brand on the request of end user department, failure to provide the demanded/desired brand, RFQ shall be floated again, or order shall be awarded to the second lowest firm (based on highest offered discount rate).
- 8. A minimum threshold 6% discount rate for all Surgical Disposable approved by the SHC & ME department to be set for all participating vendors in LP procurement process. The quotation with minimum rate of the required brand and acceptable quality product shall be selected & invoice will be generated accordingly.
- 9. In case of matching rates re-bid would be resorted at the first instance. Giving minimum time for offering bids would be fixed at 30 minutes. However if no one will respond then the nearest vendor of the Hospital would be contacted / ordered for provision of required article. All successful prequalified bidders are bound to submit RFQ in case of risk purchase the amount will be equally divided among all successful bidders.
- 10. In case procuring agency requires verification/conformation of quoted price(s) against any item(s), Procurement Department of PKLI & RC may ask the applicant to provide the Purchase order of other institutes for the relevant item. The procuring agency may ask the vendor to provide the invoice of sole distributor for price verification. In case item is procured from open market than purchase invoice will be demanded for cross reference.
- 11. Upon verification if it is found that quoted price is more than market/trade price, issued purchase order shall be cancelled and may award to the second lowest applicant or RFQ shall be floated again.
- 12. The discount rate option shall be kept open as to necessitate maximum competition and to ensure quality of medicines.
- 13. Delivered product shall be inspected by the user department, if not according to the user's requirement, applicant/vendor shall be responsible to provide same item of other brand.
- 14. The supply order period will be as per purchase order. In case of late delivery of surgical disposable consumables (imported/local) beyond the periods specified in the purchase order penalty @0.067% per day of the cost of late delivered supply shall be imposed and deducted from bill.
- 15. The bidders with the highest offered discount rates, if not conflict in any other law, rules, regulations or policy of the Government of Punjab, shall be awarded purchase order.



- 16. The firm will have to supply the surgical disposable consumables (local/imported in the stipulated period as per purchase order.
- 17. Facility of the supplies must be available round the clock
- 18. On all the surgical disposable Date of manufacturing, Date of Expiry, must be printed
- 19. In case misbranded, spurious drugs/cut rate /franchised items or the drugs are expired without use, the firm/bidder will be bound to made free replacement on its own expenses
- 20. All prices quoted by the prequalified applicants shall be considered as inclusive of all prevailing Government taxes/ duties etc. and payable by the bidder during the currency of contract period.
- 21. Shelf life of delivered surgical disposable items must be at least 75% at the time of delivery.
- 22. Short Expiry shall not be acceptable
- 23. Every Successful applicant shall signed the contract agreement on non-judicial stamp paper.
- 24. Every Successful applicant shall provide the stamp duty @0.25%
- 25. All the intending applicants are required to submit a bid security in shape of CDR /Pay Order Bank Guarantee/ Bankers Cheque amounting to Rs.430,000 (0.5% of estimated cost) in favor of Pakistan Kidney and Liver Institute and Research Center, Lahore.
- 26. Each successful prequalified application will submit performance guarantee Rs. 645,000/- in favor of PKLI & RC which is 1.5% of total allocated budgeted amount.
- 27. Keeping in view the operational exigencies, Competent authority of PKLI shall have the authority to extend the local purchase contract up to three months to have fresh competition. The competent authority of PKLI shall also have the authority to rescind the contract without any notice and assigning any reason thereof.
- 28. In case of emergency single quotation may be asked to the prequalified applicant upto Rs. 75,000/-
- 29. In case ordered surgical disposable are not supplied by the contract within the time period mentioned in purchase order, risk purchase should be made. Whole amount shall be deducted.
- 30. Payments shall be made on issued purchase order basis.
- 31. In case prequalified firm charges excess rate, the difference will be recovered from the contractor from his other out standings.
- 32. All applicable taxes shall be deducted as per prescribed rules.
- 33. Decision made in Pre-Bid meeting shall become part of bidding document after approval from competent authority and will be shared on website.
